RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT ("RELEASE")

- 1.) I acknowledge, agree and represent that I understand the risks involved in participating in Aspinwall Tee Ball and that I am qualified, in good health and in proper physical condition to participate in such activity. I further acknowledge that the activity will be conducted in baseball fields and the terrain may be uneven at times.
- 2.) I fully understand that: (a) the act of participating in Aspinwall Tee Ball involves risks and dangers of bodily injury, including permanent disability, paralysis and death; (b) these risks may be caused by my own actions, or inactions, or by the actions or inactions of others participating in the activity, the conditions under which the activity takes place, or the negligence of the "Releasees" named below; (c) there may be other risks and social and economical losses either not known to me or not readily foreseeable at this time; and I fully accept and assume all such risks and all responsibility for personal injuries, losses, damages, costs and expenses I may suffer or incur as a result of my participation in the activity.
- 3.) I hereby release, discharge and agree not to sue the Aspinwall Tee Ball organization, The Borough Of Aspinwall, volunteers, other participants, sponsors, advertisers, neighbors, promoters, and if applicable, owners and lessors of any of the premises on which Aspinwall Tee Ball takes place, (each considered one of the "Releasees" herein) from all liability, claims, demands, losses or damages incurred as the result of my participation in Aspinwall Tee Ball (including, but not limited to claims, losses or damage caused or alleged to be caused, in whole or in part, by the negligence of a Releasee or otherwise); and I further agree that if, despite this Release, I, or anyone on my behalf, makes a claim against any of the Releasees, I will indemnify, save and hold harmless each of the Releasees from any litigation expenses, attorney fees, loss, liability, damage, or cost which any of the Releasees may incur as the result of such claim.
